



## **WHITBY GOLF CLUB LTD**

### **MEMBERSHIP SCHEMES TERMS AND CONDITIONS**

#### **FULL PLAYING**

##### **ALL PLATINUM, COUNTRY AND JUNIOR MEMBERSHIPS ALL AGE CATEGORIES**

- 1) Members on this scheme will be entitled to unlimited golf and have the option to either pay in full or by standing order of 10 monthly payments.
- 2) Open to all new members.
- 3) Open to all existing members.
- 4) Can enter all club competitions subject to conditions of entry.
- 5) Can represent the club in Inter Club or Alliance matches subject to conditions of entry.
- 6) Can join internal club sections subject to payment of any additional membership fees.
- 7) Can sign in guests at a discounted rate of 50% of full green fee rates i.e. not discounted/reduced rates.
- 8) Has full use of clubhouse facilities and social events.
- 9) Can rent lockers.
- 10) Can use all the practice areas of the course.
- 11) Can attend club meetings and vote on all club matters.

##### **Conditions of Membership/Restrictions**

- 1) For existing members all membership fees must be either paid in full or have a standing order in place for payment of fees at the start of the new membership year.
- 2) Members who have not paid their membership fees by 1<sup>st</sup> March will not be entitled to either play on the course or enter competitions until the outstanding fees have been settled.
- 3) Where members decide to discontinue membership they must send a letter of resignation to the Club Manager by end of February. No refunds will be given where resignations are during an existing membership year.

##### **ACADEMY**

- 1) Open to all new members who are either new to golf and have not been a club member previously.
- 2) Cost is £275 inc affiliation fees plus £4 insurance. Members on this scheme will be entitled to unlimited golf and have the option to either pay in full or by standing order of 6 monthly payments.
- 3) Academy Members may transfer to a Platinum membership during their membership year the cost of which will be calculated on a pro rata basis.
- 4) Can enter club competitions subject to conditions of entry excluding main board (trophy), matchplay and knockout competitions. Can win prizes and prize vouchers, but not trophies.
- 5) Can join internal club sections subject to payment of any additional membership fees.

- 6) Has full use of clubhouse facilities and social events.
- 7) Can use the practice areas of the course.
- 8) May attend club meetings, but not entitled to vote on club matters.

#### Conditions of Membership/Restrictions

- 1) Where members decide to discontinue membership they must send a letter of resignation to the Club Manager by 28<sup>th</sup> February. No refunds will be given where resignations are during an existing membership year.
- 2) Cannot sign in guests at a discounted rate.
- 3) Cannot represent the club in Inter Club or Alliance matches.
- 4) Cannot rent lockers.

### **RESTRICTED PLAYING**

#### **GOLD & SILVER**

- 1) Open to all new members.
- 2) Open to all existing members at the start of a new membership year i.e. 1<sup>st</sup> February. Transfers not allowed during a current membership year.
- 3) Gold - £399 inc affiliation fees plus £4 insurance. Members on this scheme will be issued with 20 membership tokens which entitle him/her to 20 rounds of golf.
- 4) Silver - £249 inc affiliation fees plus £4 insurance. Members on this scheme will be issued with 10 membership tokens which entitle him/her to 10 rounds of golf.
- 5) Membership tokens are valid during any single membership year 1<sup>st</sup> February to 31<sup>st</sup> January. Fees must be paid in full at the start of the membership period.
- 6) Unused membership tokens cannot be transferred to subsequent membership years.
- 7) Gold Members are entitled to purchase additional membership tokens rounds in blocks of 5 at £75 i.e. £15 per round. Unused tokens for additional rounds can be carried over to the next membership year only subject to the member rejoining the same membership scheme.
- 8) Member entitled to purchase additional membership tokens rounds in blocks of 5 at £100 i.e. £20 per round. Unused tokens for additional rounds can be carried over to the next membership year only subject to the member rejoining the same membership scheme.
- 9) Gold and Silver Members may transfer to a Platinum membership during their membership year the cost of which will be calculated on a pro rata basis. Unused membership tokens cannot be used to offset any costs associated with this change.
- 10) Can enter club competitions subject to conditions of entry excluding main board (trophy), matchplay and knockout competitions. Can win prizes and prize vouchers, but not trophies.
- 11) Can join internal club sections subject to payment of any additional membership fees.
- 12) Has full use of clubhouse facilities and social events.
- 13) Can use the practice areas of the course adjacent to the Pro Shop.
- 14) May attend club meetings, but not entitled to vote on club matters.

#### Conditions of Membership/Restrictions

- 1) Tokens can only be used by the named member. They may not be transferred to other players or used to pay green fees for guests.
- 2) Cannot sign in guests at a discounted rate.
- 3) Must sign in and redeem one membership token either at the Pro Shop or designated alternative location before commencement of play.
- 4) Cannot practice on the course in areas away from the Pro Shop unless they have signed in as specified and redeemed a membership token.

- 5) Cannot represent the club in Inter Club or Alliance matches.
- 6) Cannot rent lockers.

### **125<sup>th</sup> ANNIVERSARY ASSOCIATE**

- 1) Open to all new members.
- 2) Open to all existing members at the start of a new membership year i.e. 1st February. Transfers not allowed during a current membership year.
- 3) Cost is £125 flat fee (not pro rata) plus £4 insurance and £12.50 green fees for every round played.
- 4) Validity period 1st April to 31st October 2017. Access to the course 7 days a week subject to tee time availability.
- 5) Must book in advance with Pro Shop and sign in on arrival.
- 6) Non -transferrable – named individual only.
- 7) Has full use of clubhouse facilities and social events.
- 8) Can use the practice areas of the course adjacent to the Pro Shop immediately prior to a paid for round.
- 9) May attend club meetings, but not entitled to vote on club matters.

### **Conditions of Membership/Restrictions**

- 7) Cannot sign in guests at a discounted rate.
- 8) Must book in advance of play with Pro Shop and sign in on arrival.
- 9) Cannot practice on the course in areas away from the Pro Shop.
- 10) Cannot play in club competitions, represent the club in Inter Club or Alliance matches.
- 11) Cannot rent lockers.

### **PARENT/GUARDIAN**

- 1) Open to all new members.
- 2) Open to all existing members at the start of a new membership year i.e. 1<sup>st</sup> February. Transfers not allowed during a current membership year.
- 3) Cost is £100 plus £4 insurance.
- 4) Members on this scheme are entitled to play on the course when accompanying their child who is a Junior member of the Whitby Golf Club.

### **Conditions of Membership/Restrictions**

- 1) Where members decide to discontinue membership they must send a letter of resignation to the Club Manager by 28<sup>th</sup> February. No refunds will be given where resignations are during an existing membership year.
- 2) Not entitled to hold and Handicap or enter Club Competitions.
- 3) Cannot sign in guests at a discounted rate.
- 4) Cannot represent the club in Inter Club or Alliance matches.
- 5) Cannot rent lockers.
